The Green Globes online questionnaire, Google Maps, and other documentation was reviewed with the above listed documents.

The Green Globes for New Construction (NC) assessment is a review of your responses to the Green Globes questionnaire as well as documentation of the facility design including construction documents, book specifications, and other design considerations.

Users find the Design Review assessment more helpful when it occurs prior to actual construction as it indicates if the building appears to be on target for achieving a certified rating and what additional information, if any, will be needed. The Onsite assessment occurs after construction is complete and includes an onsite walk through of the facility, review of additional documentation that may have been missing or not available during the Design Review, and interviews of key team members. Based upon the Design Review assessment, my preliminary assessment is that the PROJECT should receive a Two Green Globes rating if your Onsite assessment confirms that the planned sustainable policies and features have been implemented. The preliminary Green Globes score for your project is 569.5 points out of 954.5 applicable points or 60%. In order to achieve the next higher Green Globes rating, you would need to increase your score by 99 points.

This project is a good example of sustainable design and the integration of design professionals in that process. The team considered the impact of design decisions and their influence on the day to day operations of the facility as well as the long-term benefits to the building owner.

You are well-positioned to achieve a Green Globes certified building. If all of the design parameters for which points were granted during the Design Review assessment are installed and implemented during construction and verified during the Onsite visit, you should achieve a Two Green Globes rating for the building based on a projected overall score of 60%.
